Arkesden Partners is pleased to present our quarterly report tracking people moves, named HeadCount, chronicling UKbased Private Equity moves within four key functions of the asset class for Q2 2023.

The functions covered are PE Investment Teams, Investor Relations, Portfolio Operations and Capital Markets. The report also includes an 'Other' section for particularly interesting moves outside of this.

The early 2023 market saw our client base operate with increased hiring discipline in light of a high inflation and high interest rate macroeconomic environment, with activity levels therefore lower than previous peaks in late 2021 and 2022. This report details 102 hires across our basket of 150 funds, with particular activity spikes in areas of market resilience (e.g. Healthcare), market necessity (IR & Fundraising), and market growth (Secondaries/LP Strategies). Most hires have been more 'regular' Associate resourcing hires, but a number of interesting more senior moves are also detailed.

The following pages lay out these moves in a table format to allow for quick and easy navigation, sorted by function. Hiring firms are then ordered alphabetically within each function. We then include a few pages of commentary and trend analysis, looking at hiring volume, gender, and level.

Notes on methodology

This report is designed to provide an insight into key market moves and team builds, across the junior, mid and senior levels, where individuals started their new role during April-June 2023. Data is based on a basket of 150 key funds and their teams in the UK.

The report is designed to be informative but cannot claim to be comprehensive, and focuses on Investment teams, IR/Client Solutions teams, Capital Markets teams, Portfolio Operations teams, and other key moves of interest.

This report does not cover wider middle and back offices hires within the investment firms covered. Arkesden may have been involved in placing some of these hires, but to protect client confidentiality, in these cases we have only listed placements which have since been made publicly available.

Note: Any group percentages not adding up to 100% in the following section will be caused by rounding particularities.



ADDITIONAL ANALYSIS & COMMENT

35-40% WOMEN HIRES IN THIS REPORT

GENDER

35-40% of the hires highlighted in this report are women. Broken down by function:

- PE Investments: 40-45%
- Investor Relations: 35-35%
- Portfolio Operations: 15-20%
- Capital Markets: 30-35%
- Other: 0% (of 1 hire highlighted)

While encouraging to see gender diverse hiring peaking in PE investment roles, and moving closer towards 50% both in that function and overall, we note that there clearly remains room to grow in this aim across all functions highlighted in the report.

This rate of hiring does compare favourably with our 2022 Gender Diversity Report, which found that 20.5% of PE investment team staff in London at the time were women. This could be an indication that our 2024 Gender Diversity Report should discover a higher total proportion.



As in our bi-annual PE Gender Diversity Report, Arkesden groups levels by 4 categories in our reporting:

Level 1


Analyst / entry-level Associate (i.e., hired from advisory), or equivalent.

Level 2

Senior Associate / Vice-President / Investment Manager / Associate Director, or equivalent. 'Senior' Associate hires will include Associates moving laterally with a significant amount of previous investment experience (18 months or more).

Level 3 Director / Principal, or equivalent.

Level 4 Managing Director / Partner, or equivalent.



Other Interesting Trends of note

Junior hires were most pronounced in PE investment teams, with 68% of hires being Analysts / Associates, vs just 1.5% of hires being MDs / Partners (IMs / VPs being 21% and Directors / Principals being 10.5%). This reflects well-established approaches to talent for the majority of PE firms.

Portfolio Operations hiring spikes at the VP / IM level, likely reflecting the desire for more mature and experienced hires into this function. 45% of hires were IMs / VPs, with 27% being Analysts / Associates, 18% being Directors / Principals, and 9% being MD / Partners.

Investor Relations hiring was more balanced but also reflected a desire for more senior, established talent. The MD / Partner hiring rate here was 11%, higher than any other core function, while 21% of hires were Directors / Principals and 21% again were IMs / VPs. Just under half of IR hires were Analyst / Associates (47%).





43% WOMEN TOTAL ANALYST & ASSOCIATE HIRES

GENDER BY LEVEL

57% of the total VP / IM hires we reported were women. This includes:

- Just under 65% of the PE Investment team VP / IM hires we reported (vs 25% of VPs / IMs evaluated in our 2022 Gender Diversity report being women).
- Half of the Investor Relations VP / IM hires we reported.
- 40% of the Portfolio Operations hires we reported.

43% of the total Analyst / Associate hires we reported were women. This includes:

- Half of the Capital Markets Analyst / Associates hires we reported.
- Just over 45% of the PE Investment team Analyst / Associate hires we reported (vs 35% of the Analysts / Associates evaluated in our 2022 Gender Diversity report being women).
- Just under 45% of the Investor Relations Analyst / Associate hires we reported

This report did not identify any women hired into Director / Principal or MD / Partner level positions across these functions and the time period covered in our basket of funds.
